GRAHAM SUPPORTS PARENTS IN WORKING TOWARD THE GOAL OF REUNIFYING WITH CHILDREN, AND WHEN PARENTS CANNOT PROVIDE FOR THEIR CHILDREN'S SAFETY, WE SEEK AN ALTERNATIVE STRONG, PERMANENT FAMILY THROUGH KINSHIP CARE OR ADOPTION. IN FY2025, WE PROVIDED FOSTER HOMES, CASE MANAGEMENT SUPPORTS AND CARE COORDINATION TO OVER 900 CHILDREN IN FOSTER CARE TO ENSURE THEIR SAFETY AND WELL-BEING.

SEVENTY FIVE PERCENT (75%) OF YOUNG ADULTS AGES 21+ IN GRAHAM SLAM EARNED THEIR HIGH SCHOOL DEGREE, COMPARED WITH 24% OF NYC ADULTS WHO HAD BEEN IN FOSTER CARE HISTORICALLY WITHOUT A COACH.

EACH YEAR, WE PROVIDE TRAUMA-FOCUSED THERAPY TO CHILDREN AND ADOLESCENTS IN OUR FOSTER CARE AND FAMILY SUPPORT AND EMPOWERMENT SERVICES, AS WELL AS CHILDREN AND YOUTH WHO ARE REFERRED THROUGH HOSPITALS OR LEARN ABOUT OUR SERVICES IN OTHER WAYS.
